Territorial Disputes in the Shadow of Law: Effect of International Law on Use of Force and Third-Party Responses

How the strength of legal claims shapes the use of force in territorial disputes and third-party responses. The first two papers examine the use of force and peaceful resolution between disputants; the remainder of the dissertation draws on an original third-party intervention dataset to show that the disputants' legal claims shape the probability and severity of the third-party interventions.

Job Market Paper

[“Territorial Disputes in the Shadow of Law: Legal Claims and the Use of Force”](#)

Asks when legal claims to disputed territory restrain—or license—military force, using dispute-year analysis of an original extension of the Huth–Croco–Appel data on post-1945 territorial disputes. Finds that a challenger's stronger legal claim emboldens it where the challenger holds a clear military advantage and pacifies it at or near military parity, and that a target's stronger legal claim deters the use of force.

Work in Progress

“Legal Claims and Peaceful Resolution: How Strong Legal Claims Facilitate or Prevent Resolution.”
Second dissertation paper.

Finds that a challenger's strong legal claim facilitates the peaceful resolution of territorial disputes, while a target's strong claim hinders or stalls it.

“AI Writes the Dissenting Opinion: Why AI Agents Systematically Disagree with Legal Claims Datasets.” *Abstract submitted to A Field Guide to Using AI Agents in Political Science (eds. Sarah Dreier and Charles Crabtree).*

Replicates the Huth–Croco–Appel legal claims coding with AI coders (GPT and Claude) across 168 territorial disputes, 1945–2025. AI coders produce internally consistent claim-strength values that systematically diverge from the human-coded values and adhere more closely to ICJ case law, while under-

performing at independent fact-finding and at restricting themselves to the law applicable at the time.
Develops a structured, repeated-run API protocol for stable AI coding of legal variables.

Original Datasets

Legal Claims and Third-Party Interventions in Territorial Disputes

Intervention-level data on third-party diplomatic, economic, and military responses across 94 post-1945 territorial disputes; coding designed and supervised across two six-member undergraduate research teams (twelve coders) over two years.

Territorial Militarized Interstate Disputes, 1945–2014

Identifies and codes territorial MIDs directly from the Gibler and MID 5.0 narratives and independent sources, matching each MID to its underlying territorial dispute—recovering territorial MIDs that existing MID projects code as non-territorial.

AI-Coded Legal Claim Strength in Territorial Disputes, 1945–2025

Claim-strength codings and full legal-reasoning transcripts for 168 territorial disputes, generated through a structured and repeated-run protocol (OpenAI and Anthropic APIs) that replicates the Huth–Croco–Appel coding scheme and presents a parallel scheme based on ICJ jurisprudence.
